2. EVALUATION CHARACTERISTICS.

2.1. GAME DESCRIPTION.

Game rules are contained in the help files accessible on the individual game play skin. There are three types of games evaluated by BMM; multi-HTML5, 'DH' and 'MH'. 'DH' type games are standard desktop games. 'MH' games are designed to run on Mobile phone and tablets; however, these games can still run on typical browsers. Games not denoted are multi-HTML5 where the game is can be launched the same on either device type.

2.1.1. Heartburst (DH, MH) & Heartburst JP (DH, MH) v 3.1.8

Heartburst is a 5-reel, 100-payline slot with expanding substitute and free games feature. Game can be configured to operate with or without additional Jackpot.

2.1.2. White Wizard Deluxe (DH, MH) v 3.1.6

White Wizard Deluxe is a 5-reel, 100-payline slot with expanding substitute and free games feature.

3.1. Software Evaluation

Ensure that software meets all the relevant requirements specified in Isle of Man market. BMM performed this by evaluating all the game source code.

3.2. Artwork Verification

Artwork was evaluated to ensure that it correctly explains the game rules and payouts as specified in the technical documentation supplied by the manufacturer and that it conforms to the requirements of Isle of Man market.

3.3. Mathematical Evaluation

Verification of the different probabilities per each type of bets of the game.

3.4. Combination Testing

Combination testing was conducted by simulating all possible winning combinations from each game to ensure that the correct amount of credits is awarded for all possible winning combinations reflected on artwork.
